PEEL Mirror System Care and Maintenance

To obtain the maximum life of your PEEL Mirror System the following instructions should be followed.

- **Cleaning Solutions**
 - Most glass cleaners will work to clean your PEEL Mirror System although we do recommend a foaming glass cleaner like Spray Away type products.
 - Please do not use any harsh cleaners as they could affect the longevity of the mirror.
- **Cleaning Materials**
 - Always use fresh and clean, soft materials to wash and dry your PEEL Mirror Kit. A soft cloth is a microfiber or similar. A squeegee can be used if the blade is clean and free of any damage.
 - To avoid scratching the film, do not use bristle brushes, abrasive scrubbing sponges or any cleaning materials that may have been contaminated with dirt particles, as is commonly the case when washing interior and exterior windows with the same cleaning materials. Some brands of paper towels are course enough to put fine scratches in the film, even our films with a protective hard coat finish. While these scratches may be too thin to be seen at the beginning, they can damage the polished look of the film over time and is not covered by our warranty.

PEEL Mirror System Warranty

What is covered:

Property Protection International, Inc. warrants the PEEL Mirror System for 1 year (12 months) from date of purchase against the following:

- **Mirror Shield corrosion.**
 - Silvering on film becomes oxidized and shows thru.
- **Mirror Shield adhesive failure, crazing, delaminating.**
 - Any adhesive bubbling that may occur in many pockets.
 - Crazing or a network of small cracks in film.
 - Delaminating film in ways the material layering is separating.
- **Acrylic to metal backing adhesion or failure.**
 - Acrylic to metal backing has separated or come apart.

What is not covered:

- Any installation that is not done per the installation guidelines.
- Mirrors mounted and touching sink top or sitting in water. This can cause corrosion and will not be covered.

How to Apply for a Warranty:

To be eligible for coverage under this warranty, Property Protection International, Inc. must have paid proof of purchase from Property Protection International, Inc., or distributor. Photos must accompany any claim for proof of any issue and for quality purposes.

No contractor, including the PEEL Mirror System distributor/installer, has any authority or power to modify or extend this limited warranty. The benefits under this warranty shall be the sole and exclusive remedy against Property Protection International, Inc. for any loss arising out of the sale, application, and/or use of the mirror.
3. This warranty coverage is valid only in the United States of America and Canada. If any provision of this warranty is unenforceable or ineffective, the rest of this warranty shall remain in effect and be construed as if such provision had not been contained in this warranty.
4. This warranty shall be governed by California law, excluding its laws relating to choice of law. Regardless of what venue would otherwise be permissive or required, Property Protection International, Inc. and the customer stipulate that all actions arising under or related to this warranty shall be brought in the federal or state courts located in Orange County or the City of Anaheim, CA. Property Protection International, Inc. and the customer agree that either of such forums are mutually convenient and bears a reasonable relationship to this Agreement and waive objection to any venue laid therein.
